TOPIC DISCUSSION

NCAA Guideline – Concussion or Mild Traumatic Brain Injury

Dr. Sehgal discussed concussion management and the NCAA and the Florida HSAA guidelines and the recent legislation that had passed and is effective July 1, 2012. Copies of this legislation were provided in the agenda – HB 291 and SB 256. The Board was concerned and asked that a letter be sent regarding cheerleaders and concussions and they be included in this legislation.

NCAA Guideline – Prevention of Heat Illness

Dr. Sehgal discussed NCAA guidelines for the prevention of heat illnesses and the legislation that was passed by New Jersey regarding this. She would like to see the Board take initiative to pass similar legislation in Florida this next year. She requested that copies of the New Jersey guidelines be sent to board members for review.
